Nomination forms should be handed over to the undersigned personally by the candidate or by his/her Proposer or Secunder on the date and time mentioned above together with the **cash security of Rs. 1000/-** In case the candidate gets less than 1/6<sup>th</sup> of the total votes



polled, the security deposit shall be forfeited and such candidate shall be disqualified from contesting the election in that society for a period of three years. No Person shall be eligible to contest election on two seats simultaneously. The Proposer and Seconder shall not be defaulters. A member shall not be eligible to contest for the election if he has not completed minimum period of one year from the date of acquiring membership in the society to the date of filling of the nomination.

The list of members along with the list of Defaulter members of the aforesaid Society shall be displayed at the office of the undersigned and the notice board of the society, for information of the members. Interested member can obtain the membership list from the society office against payment of prescribed fees, as per provisions of DCS Rules, 2007 (as amended from time to time).

### SPECIAL NOTE

The meeting shall start at 11.00 A.M. on 09.10.2022 at MCD Community Hall, Ground Floor, Dabri (Near Telephone Exchange) New Delhi-110046, the quorum of the meeting will be observed up to 11.30 A.M. In case the quorum is not complete within given time, the meeting shall be adjourned for Fifteen Minute i.e. from 1.30 A.M. to 11.45 A.M. The adjourned meeting for the election shall take place from 11.45 A.M. to 5.00 P.M. on 09.10.2022 at the same place. In the adjourned meeting no quorum shall be necessary in terms of the amended rules 48(3) of the DCS Rules, 2007.

NITE: 1. As per provisions in the DCS Act 2003 and Rules 2007, the defaulter members are not eligible to contest the election nor they are entitled to cast their votes like those members against whom decree has been issued under section 61. However, in case, if they make the payment of their amount in default before the date of filing of nomination to the society and produce the proof thereof before the Election Officer, they will not be treated as defaulters and shall be allowed to contest the election. It is further informed that no person shall be eligible to contest election if he incurs disqualification as laid down under rule 54 of the DCS Rule 2007.

2. All the members are requested to bring the proof of their identification by way of Pass Book of the society, Driving License, Identity Card issued by the Election Commission of India or any other documents related for their identification to facilitate the smooth conduct of election.
